Within 7 days of pick-up, we will send you a kit that will include instructions and a bag for you to secure all of the materials.

All containers must be less than 5 gallons, must not be leaking, and must be properly labeled and secured in the packaging from the kit we send you. Our Customer Service Representatives will answer any questions about proper disposal for unacceptable materials or quantities larger than 5 gallons.

What is HHW?

Leftover household products that contain corrosive, toxic, ignitable, or reactive ingredients are considered to be household hazardous waste (HHW). These products require special care when you dispose of them.

Benefits of Proper HHW Management

- Reduction and recycling of HHW conserves resources and energy that would be expended in the production of more products.
- Reuse of hazardous household products can save money and reduce the need for generating hazardous substances.
- Proper disposal prevents pollution that could endanger human health and the environment.

So before you toss it, consider the following:

- Latex paint is not a hazardous waste. Consider donating it to community groups or other organizations for re-use!
- Many automotive stations, auto parts stores and supply stores will accept used motor oil for recycling.
- Automotive batteries may be exchanged at the place of purchase, or turned in at some battery retailers and scrap yards.

Acceptable Materials

- Automotive Products (vehicle batteries, antifreeze, brake fluid, cleaners, hydraulic fluid, transmission fluid, motor oil, oily rags, polishes, waxes, used oil filters)
- Garden Chemicals (insect sprays, weed killers, other poisons, fertilizers, pesticides/herbicides)
- Paint (latex, oil-based, stripper, thinners, artists' paint)
- Household Cleaners (bleach, cleaning compounds, floor stripper, drain cleaner, tile remover, tile cleaners, rust remover, wood preservatives, corrosive chemicals (non-commercial), lye)
- Flammable & Combustible Materials (gasoline and diesel fuel, solvent, certain cleaners/waxes)
- Swimming Pool Chemicals (pool acid, chlorine tablets/liquid)
- Mercury-Containing Devices (thermostats, thermometers, switches, other devices)
- Miscellaneous Household (hobby glue, driveway sealer, other poisonous/flammable/combustible materials, batteries, household fluorescent tubes and CFLs)
- Consumer electronics



Unacceptable Items

- Unknown/Unlabeled Materials
- Pressurized Cylinders
- Ammunition
- Explosives
- Leaking Containers
- Containers Over 5 Gallons
- Commercial Products
- All Medications
- Empty Containers
- Asbestos
- Tires
- Fire Extinguishers
- Liquid Mercury
- Appliances
- Business Supplies from Home
- Trash, including bulky items
