New Wilmington Borough Council Minutes

July 7, 2025, Meeting

President John Geidner called the meeting of Council to order in the Council Chambers at 6:30pm.

President Geidner led the Pledge of Allegiance

Roll Call:

<u>Approval of Minutes:</u> Cherry Poteet made a motion to approve the previous month's meeting minutes. Kiersten Reiber seconded. Motion carried unanimously.

Approval of Bills: Ken Hilke made a motion to ratify the payment of the previous month's bills. Dave Hunter seconded. Motion carried unanimously.

Public Comment:

Sue Goodwin – Sue expressed three concerns regarding the recent project completed by People's Gas. First, they tore up her front yard and failed to clean up afterward; she is requesting that the Borough address the mess left behind. Second, a pile of gravel was left in her yard, which she is asking to have removed. Third, her sidewalk is now cracked, and she is requesting that it be repaired. Superintendent Bard Latimer will contact Peoples Gas to request that they address these issues.

Diane Richardson – Diane Richardson, on behalf of the New Wilmington Area Business Association, is requesting the Borough's support for the installation of parking signage. The request includes three public parking signs and two directional signs, for a total of five signs.

Beth Verterano – Beth Verterano requested the installation of a speaker system. Additionally, now that work sessions are being held, she asked that "Old Business" be included as a regular item on the agenda.

Committees - Formation and Duties:

John Geidner made a motion to create a business recruitment and retention committee. Cherry Poteet seconded the motion. Motion carried unanimously.

John Geidner made a motion to create a property maintenance committee. Ken Hilke seconded the motion. Motion carried unanimously.

John Geidner made a motion to create a community activities committee. Ken Hilke seconded the motion. Motion carried unanimously.

Police: Ken Hilke made a motion to approve resolution 2025-04, which confirms and ratifies its agreement to provide police services to Wilmington Township, Mercer County. Cherry Poteet seconded the motion. Motion carried unanimously.

Streets: LeeAnn Miller made a motion to pay Shields Asphalt Paving \$120,270.80. Kiersten Reiber seconded. Motion carried unanimously.

Parking Signs: Cherry Poteet made a motion to install three public parking signs at the entrances of the public parking lots that will be designed by the streetscape committee. Ken Hilke seconded the motion. Motion carried unanimously.

Business Sign: Cherry made a motion to install a directional sign at the corner of Neshannock Avenue and Market Street indicating the direction of local businesses that will be designed by the streetscape committee. Janet seconded the motion. The motion passed with four votes in favor (Janet, Cherry, Kiersten, and Dave) and three opposed (Ken, John, and LeeAnn).

<u>Sanitation/Water:</u> Cherry Poteet made a motion to accept the August 2025 Water Terminations. Ken Hilke seconded. Motion carried unanimously.

<u>Utilities:</u> Ken Hilke made a motion to accept the August 2025 Electric Terminations. Cherry Poteet seconded. Motion carried unanimously.

Municibid Auction: Ken Hilke made a motion to accept the \$9,000 auction bid for the pole truck listed on Municibid. Dave Hunter seconded the motion. The motion passed unanimously.

Zoning: Janet Robb nominated Warren Hickman to serve as a temporary member of the Zoning Hearing Board. The nomination was approved unanimously.
